The annual membership fee for the OPCC is £2,750 plus VAT (Annual Fee). Confirmed that sufficient funds are available for 12-months.

6. Driver for Change/Contribution to Delivery of the Police and Crime Plan Membership will help support the OPCC's drive to ensure rural communities get their fair share of policing.
