Executive Summary:

Humberside Police on a regular occurrence take people to Hull Royal whilst under police caution. Due to the vulnerability and violence of some people whilst under caution this can cause a disturbance and risk to other members of the public within the waiting room.

In addition to this at times officers on duty are injured and taken to the hospital waiting room in their full uniform which can create hostility to some members of the public and can put the officer in the waiting room at risk.

In order to relieve this pressure, Humberside Police in collaboration with Hull University Teaching Hospital NHS Trust have identified a side room that is vacant within the waiting area. A license to occupy at £1 per annum if demanded has been created to allow the room to be used for both Police officers and people under caution to minimise the risk and disruption within the main public waiting area.
