Executive Summary:

Humberside Police Joint Estates Service and Procurement are seeking approval from the OPCC to proceed to award the framework agreement and subsequent call-off contracts for The Provision of Measured Term Maintenance Services.

The JES manages the statutory, periodic and consequential works across Humberside Police (HP) and Humberside Fire and Rescue Services (HFRS).

This requirement is a replacement of the contract (Contract Ref: 1908-2019) previously held by J. Tomlinson & Sons Ltd. The previous route to market was an open tender conducted by the Regional Procurement Team for all four (4) Yorkshire Forces.

Moving forward it was determined by the JES that an open tender would be the preferred route to market for this requirement. The new iteration of this tender has been amended, moving away from set geographical lots to a more service orientated lot structure. The purpose of this lotting was to encourage small and medium sized enterprises to bid for the smaller and specialised service areas.

The service requirements have been separated into the following LOT's:

2. Electrical
3. Fall Arrest
4. Fire Services
5. Mechanical
6. Wet Mechanical
7. Building Services

Based on historical spend with the previous contract (Ref: 1908-2019) across the collaboration between HP & HFRS the Joint Estates Service spend circa £2.79m per annum.

The new service will commence from 1st April 2026 and will run until 31st March 2030 (48-month term contract), with a 12-month extension in place for Period 1st April 2030 – 31st March 2031.

1. Executive Summary

2. Recommendation(s)

The recommendation is for the approval from Office of Police and Crime Commissioner for Humberside (The OPCC) that following on from the open tender conducted by Joint Estates Service (JES) and Humberside Police (HP) Procurement, they are satisfied with the outcome of the results, and all considerations are in place to ensure the nominated winning suppliers can fulfil the contract.

3. Background

The Joint Estates Service (JES) have a requirement for the provision of Measured Term Maintenance (MTM) Testing and Repairs across their portfolio of sites that they manage and maintain. The statutory, periodic and consequential works for all sites to be in operational order to facilitate the requirements of Humberside Police (HP) and Humberside Fire & Rescue Service (HFRS).

The new iteration of this tender has been amended to be in alignment with the necessary specialisms, rather than one (1) whole package. Following from a full tender opportunity across all seven (7) LOT's it has been determined that these are the successful winning bidders, and we intend to notify them of the Contract Award Letter to them following on from this approval from OPCC. The winning bidders are detailed below:

Social Value:

Under the Procurement Act 2023, contracting authorities are now legally required to prioritise social value throughout public procurement—from initial planning through to contract management. This criterion is set at a minimum of 10.00% of the overall scoring criteria.

Humberside Police Procurement utilises the TOMs (Themes, Outcomes and Measures) framework, a national standard for calculating and validating social value, originally developed by the National Social Value Taskforce and now maintained within the Social Value Portal.

6. Legal Implications

This procurement requirement and subsequent call-off contracts with all nominated suppliers has been conducted and prepared in accordance with the Procurement Act 2023 and we will be using NEC4 Engineering and Construction Contract (ECC) Model Form Contract which is industry standard and recognised by agencies in this field.

Whilst the approval of this Procurement process does not directly contribute to the delivery of the Police and Crime Plan. It does provide Joint Estates Service (JES) with an essential resource to ensure both organisations are equipped and ready to meet needs of Officers and Staff at all sites across their portfolio.
